## **Things you need to send back with this application.**

- **Copy of Drivers License & Medicare Card for each borrower.**  
(if no drivers license, a copy of some official photo id... eg: Passport or Keypass)
- **Proof of current home address. (minimum of 2 items required)**  
(Eg: rates notice, tenancy agreement, gas or electricity bill with borrowers name/s & address on it)
- **Proof of Income.**  
(2 Payslips if employed. If you are self employed, we require 2 years tax returns, & bank statements. If you receive a pension, please enclose a Centrelink notice)
- **3 Months of bank statements.** (ie: Most recent statements. Preferably no more than 3 weeks old)
- **Copy of Car Rego** (needs to be current and show Rego Number, VIN & Engine Number)
- **Please provide explanation of any defaults**
- **2 Referee's need to be written on application.** (One is required to be a friend or relative NOT living with you)
